The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation, or importation of any controlled drug or narcotic substance

Includes all arrests for drug/narcotics violations in the selected year, regardless of when the crime took place. Offenders arrested on other charges are not included.

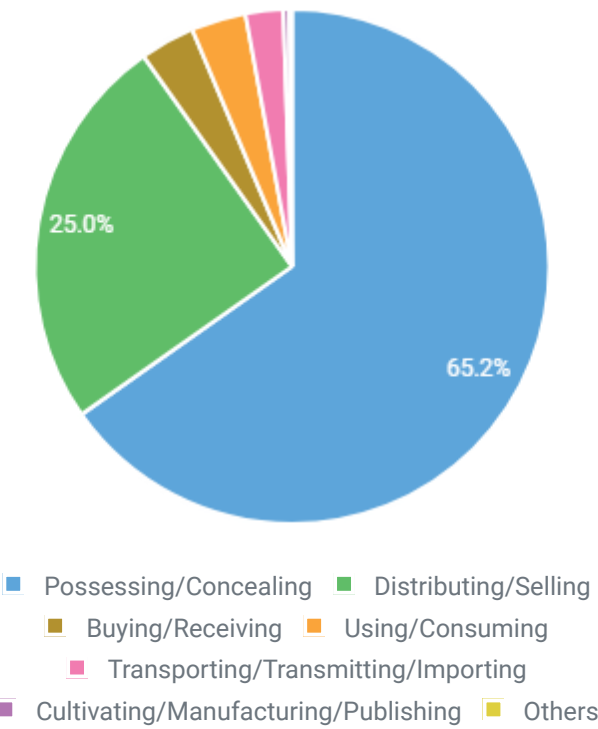

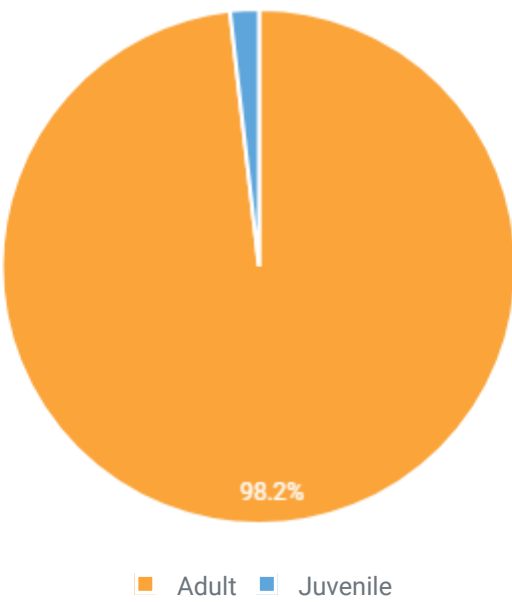

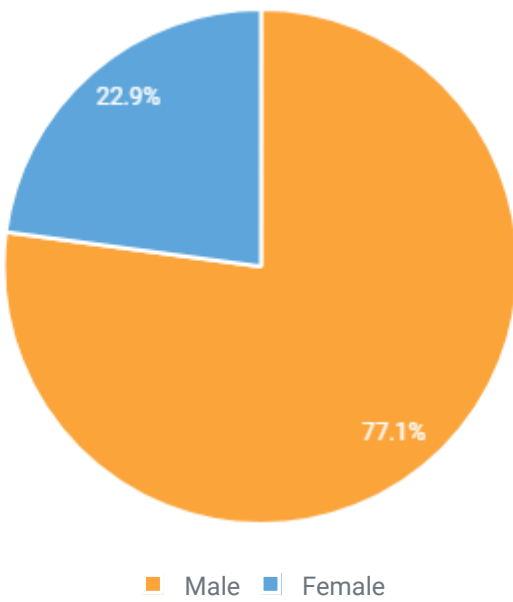
ARRESTEE AGE

Cases when drugs have been seized. Up to three drug types may be reported for any case.

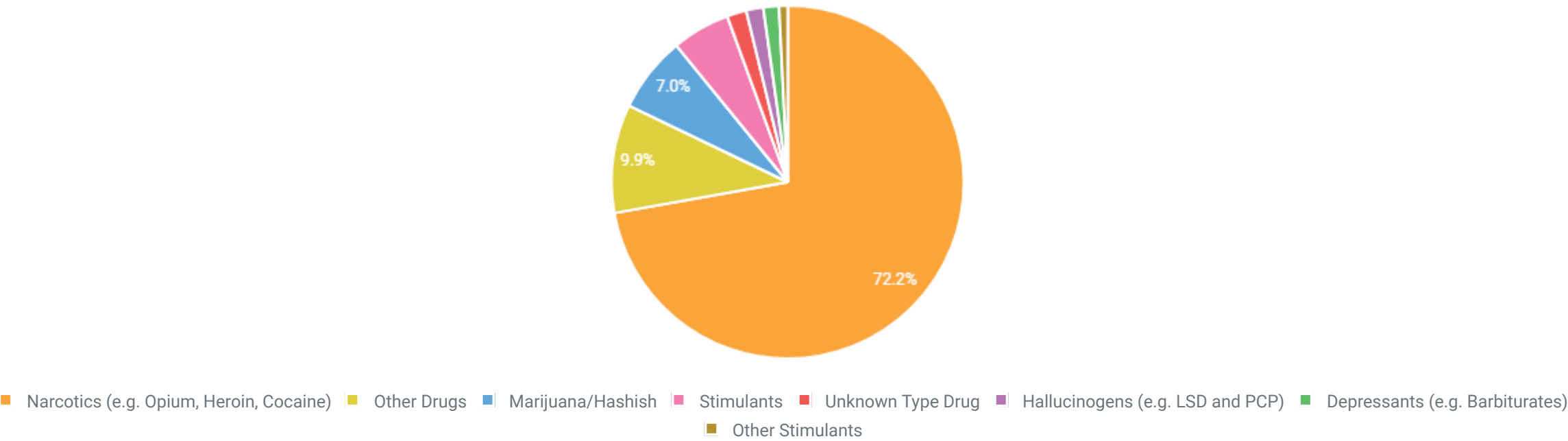

Includes all arrests for drug/narcotics equipment violations in the selected year, regardless of when the crime took place. Offenders arrested on other charges are not included.

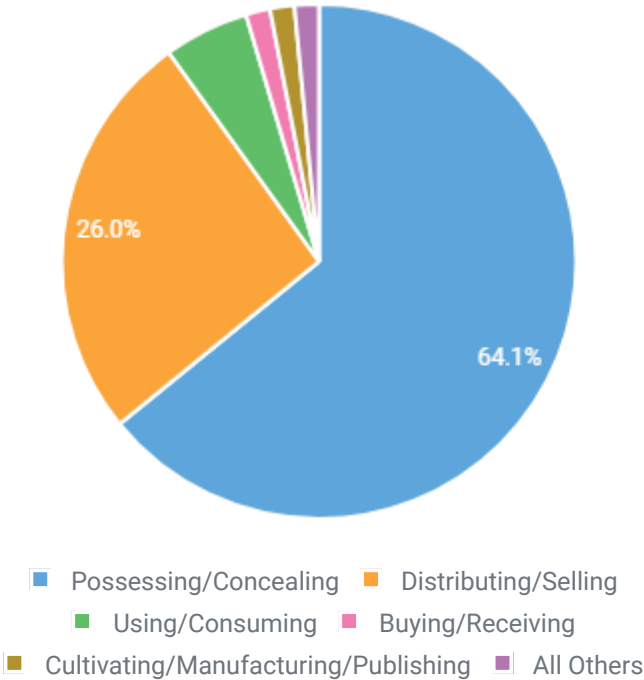

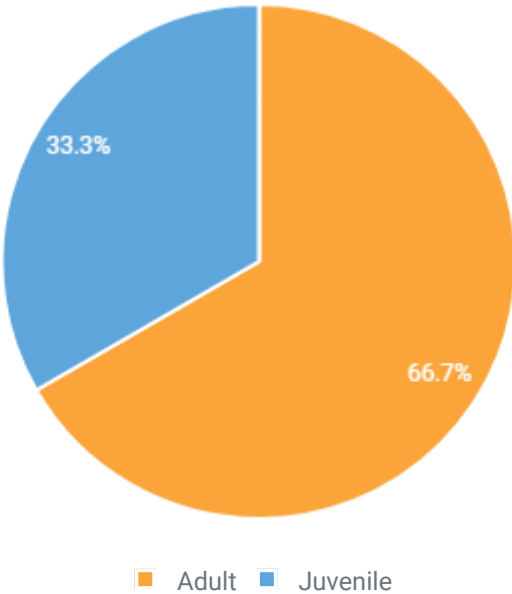

Drug Equipment Violations



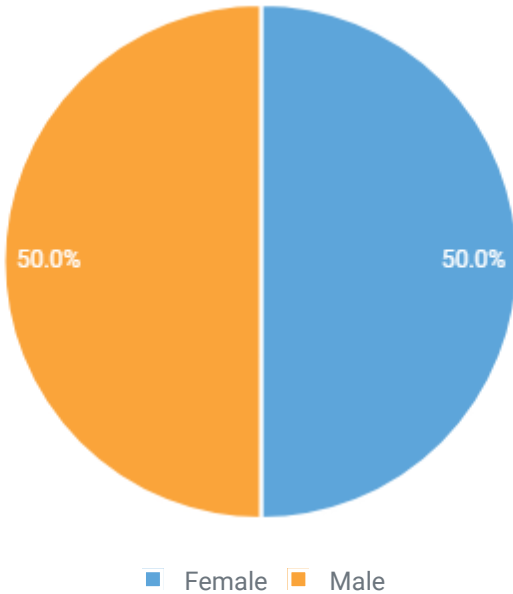
ARRESTEE AGE

Driving or operating a motor vehicle or common carrier while mentally or physically impaired as the result of consuming an alcoholic beverage or using a drug or narcotic.

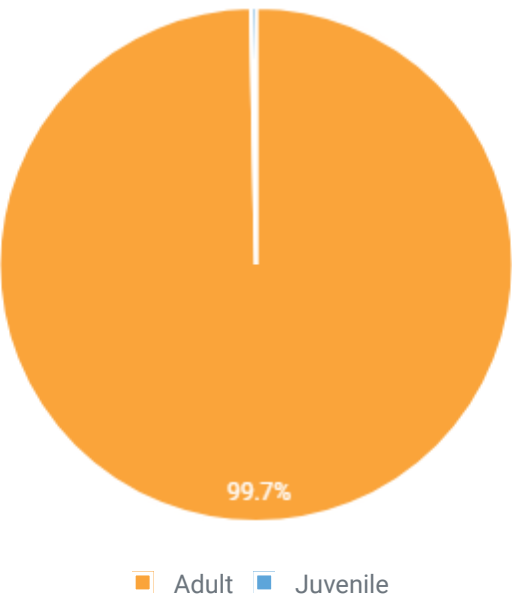

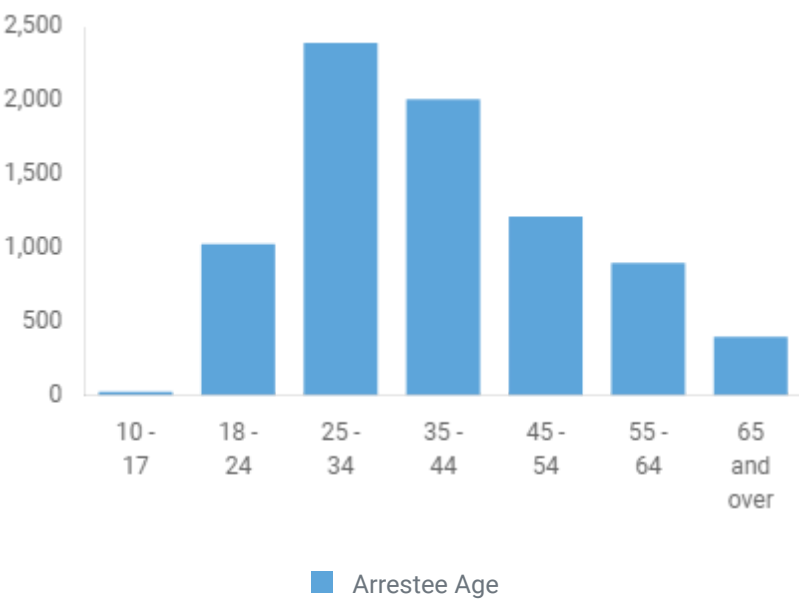

Driving Under the Influence



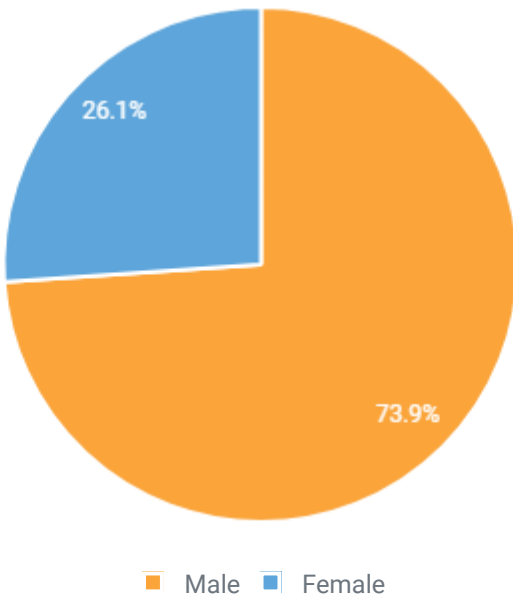
ARRESTEE AGE

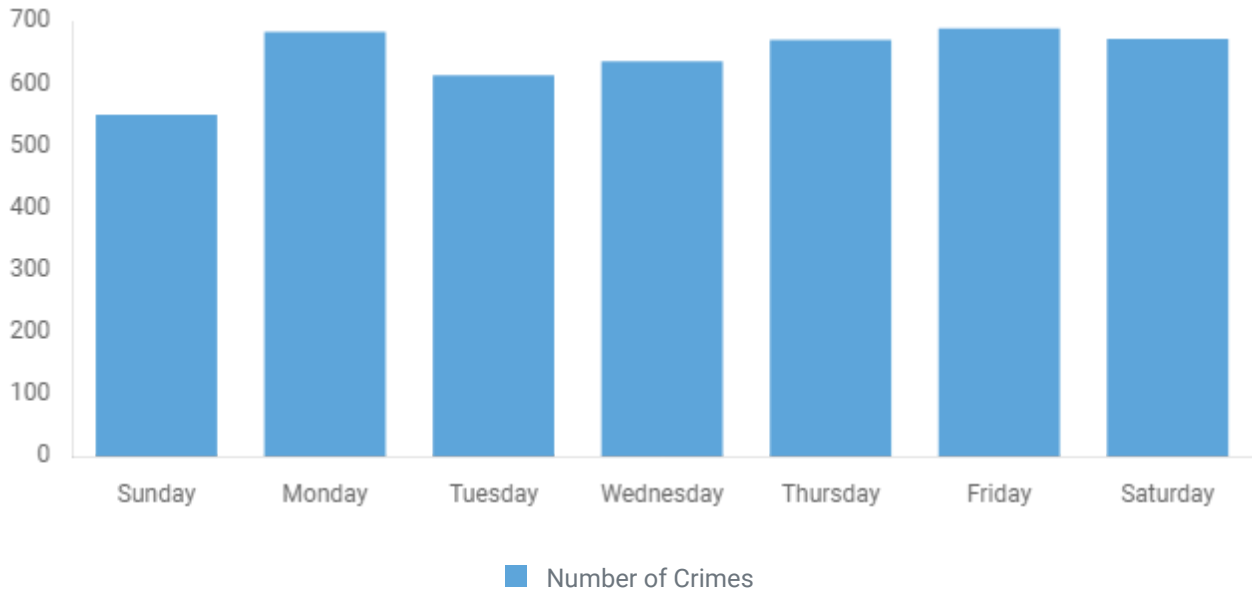

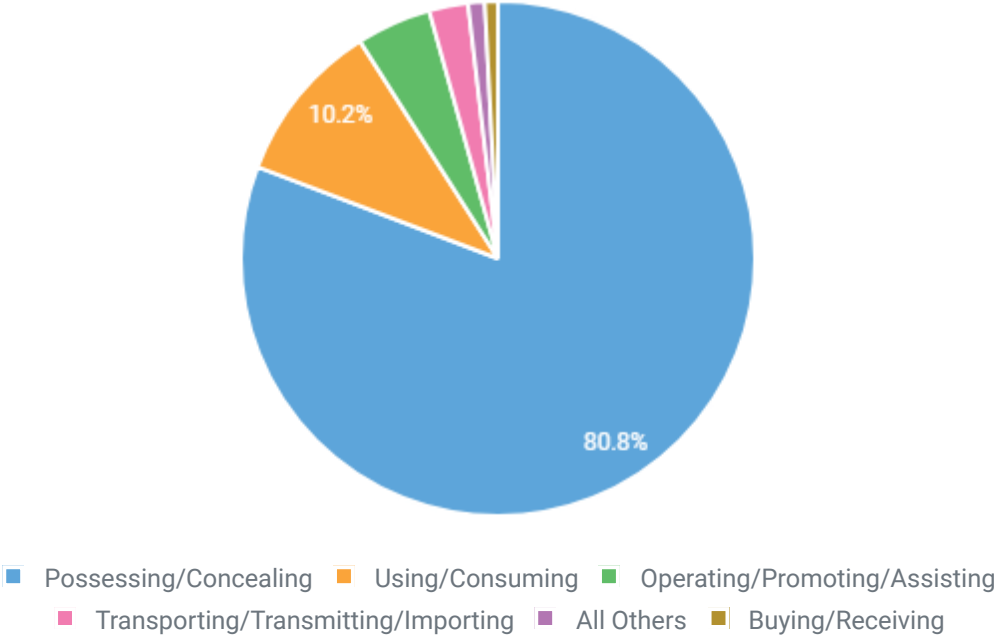

Weapon Law Violations



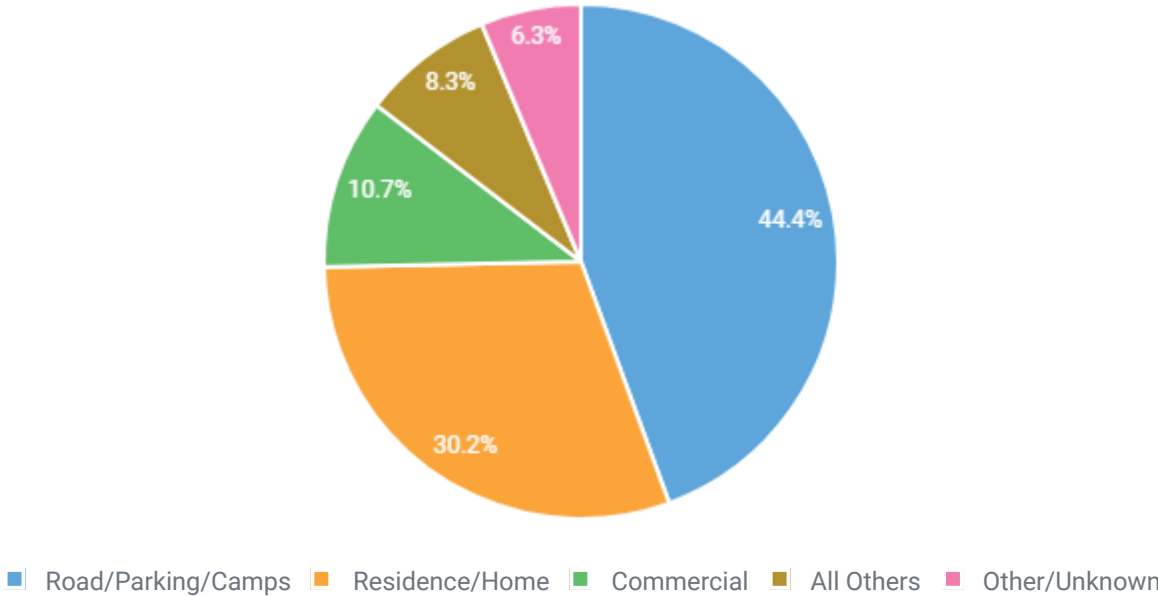
